Since its commercial launch in late 2012, FirstFuel has analyzed data for more than a million building meters, providing intelligence to utilities, energy service providers and government customers across North America and Europe. Firstfuel's FirstAdvisor product alone has analyzed 40 billion kWh and identified more than \$400 million and 5 TWh in annual savings.
